## NOTES

1. **DRILL LOCATION** - Drill will be held on the 2<sup>nd</sup> deck of Building 235, Fairchild Street, Willow Grove, PA 19044.
2. **ATTENDANCE** – NSCC Regulations have changed regarding attendance. They now state that you must attend **50% of all scheduled drills**. That is three of six drills per quarter. If you do not meet this minimum standard, you will be administratively warned. If you continue to not meet minimum attendance standards, you may be administratively discharged from the NSCC.
3. **COURSEWORK** – All Cadets must complete coursework assignments for **each promotion** within **6 months for Sea Cadets** and within **4 months for League Cadets**. **COURSEWORK IS MANDATORY!**
4. **CHOW** – The Air Force will not be drilling the weekend of 10-11 Jan and **the chow hall will not be serving lunch**. Cadets must bring their lunch with them on both 10 Jan and 11 Jan.
5. **HYDRATION** – Canteens are the only acceptable water carriers during trainings and drills. Please see supply if you need a canteen and web belt issued.
